The certificate issued by GreenSign is protected by trademark law. The client has the right to use the certification for internal and external advertising, on business documents, and for other advertising purposes in their operation for 3 years from the beginning of the certification cycle, subject to payment of the agreed annual license fees. The right to use the certification is only valid for the assessed certification criteria and the assessed operations and/or operational components. This contract will automatically renew for an additional 3 years if not terminated in writing at least 6 months before the end of the respective term. With the renewal, a new certification cycle begins as described above. The fees and license fees for the new certification cycle will be based on the price list published by GreenSign on their website at the time of contract renewal.
- The license fee for the first year of the certificate to be issued becomes due and will be invoiced with the first annual invoice upon the transmission of access data for the online tool. The license fee is due for payment within 14 days after the invoice is sent and is not contingent on whether or when the client performs the self-evaluation. This also applies to subsequent license fees. GreenSign charges an audit fee for conducting the audit. In addition, travel expenses for the auditor to conduct the audit (subsistence allowances according to tax-deductible rates, accommodation, and travel expenses) will be charged. The choice of transportation is at the discretion of the auditor. For train travel, first class is applicable for all types of trains. When using a private car, a rate of 0.70 Euro per kilometer driven will be charged. If the client cancels a scheduled appointment, they are obligated to reimburse the travel expenses already incurred and non-refundable.
